**Non-Pyrogenic** - Tested and met the criteria established in the current version of ANSI/AAMI ST 72, "Bacterial Endotoxins - Test methodologies, routine monitoring, and alternatives to batch testing" and USP <85>, "Bacterial Endotoxins Test". The acceptance level for product is  $\leq 0.05$  EU/ml or  $\leq 2$  EU/device.

**USP Class VI Testing** - All material resin is tested, qualified and shown to be non-toxic as established in the Standards USP Class VI Chapter<87>, "Biological reactivity Tests, in Vitro" and Chapter<88>, "Biological Reactivity Tests, in vivo".

Human DNA Free - Tested by PCR method and found to be free of detectable human DNA contamination. The assay detection limit is hDNA 5pg.

<code>DNase/RNase Free</code> - Tested by nuclease assay method and found to be free of detectable <code>DNase/RNase</code> contamination. The assay detection limit is  $10^{-7}$  Kunitz units/uL for <code>DNase</code> and  $10^{-9}$  Kunitz units/uL for <code>RNase</code>.
